Dt:01.01.1994 the under authority is here by accorded **Renewal Recognition to Classes I to V (EM) during the year 2019-20 to 2028-29** in respect of **Sree Vidya Peeth School, Sreepuram, Narketpally(M), Nalgonda District.**

1. That the society shall abide by the instructions/rules regulations made by the Govt. or authorized Officer time to time.
2. That the Educational Institution shall serve the needs of the locality more particularly.
3. That the institution shall adopt the curriculum and syllabus prescribed from time to time.
4. The School timings vacations and Mid-term holidays shall be as prescribed by Government from time to time.
5. That the qualified staff within the age limits prescribed by the Govt. for Govt. Employees shall be appointed as per the staff pattern.
6. That the results of Institution shall be satisfactory every year.
7. That the records/accounts shall be furnished to the District Educational Officer every year by 30th September at the latest.
8. Governing body may be constituted immediately and that the list of governing body shall be furnished to the District Educational Officer every year.
9. That the pay structure/Fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
10. That all the conditions prescribed in the G.Os and other orders, which are not specified in these orders, shall be complied with.
11. That the school shall not be closed without giving notice both to the parents/ D.E.O and competent authority at least 6 months be
12. That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
13. That the society shall submit proposed for renewal of provisional recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the recognition.
14. That the school shall be enrolled in DCEB Nalgonda and followed school timings, Term holidays like Dasahara, Sankranthi and declared 2nd Saturday as a holiday strictly.
15. As per G.O.Ms.No.91, dt:06.08.2009 and C&DSE Pro.Rc.No.780/B1-1/2013, dt:16.05.2013 the Management shall not use attractive words like "Talent", "Techno", "Public", "Olympiad", "Shastra", "IIT", "Concept", "Paradise" "Model" etc., in school name.
16. No school should sale any kind of materials in the schools.
